- e-Mitra Project is being implemented on a 3-tier model. The first level is that of DoIT&C/RISL. At the second level, there are LSPs selected through open LSP with whom they have signed MoU / Agreement.
- 3.3 RajCOMP Info Services Limited (RISL) is the executive agency under the e-Mitra project on behalf of the Government of Rajasthan.
- 3.4 District e-Governance Societies (DeGS) are Societies formed in all districts under the chairmanship of District Collector to facilitate and monitor implementation and operation of various e-governance initiatives including e-Mitra in the respective of the project at district level

2. Once the request is submitted by kiosk after confirmation from the student, no changes or corrections can be made at the end of kiosk.

- 3. Kiosk will give him the unique transaction id (mentioned on the receipt generated through e-Mitra portal) and collect the listed price of the course from the student for the subscription of the online course. (price inclusive of GST)
- 4. Necessary rate chart must be displayed by Kiosks for such purpose
- 4.1.2 Deposition of fees at e-Mitra kiosk- Student will pay the price for the
- 1. Kiosk will give him the unique transaction id (mentioned on the receipt generated through e-Mitra portal) and collect the course fees, reflected on the portal, from
- 2. The kiosk will only collect the fees reflected on the portal from the student and will not collect any other amount from the student for providing e-Mitra services.

- 5.1.2 RISL shall ensure the availability of latest and updated details of e-Mitra kiosks functioning in Rajasthan on e-Mitra portal.
- 5.1.3 Kiosk holder will generate receipt for payment for subscription of the desired online course and payment of fee on e-Mitra portal and give the same to the student.
- 5.1.4 RISL shall be responsible for the smooth & unhampered functioning of e-Mitra portal during the period of this agreement.
- 5.1.5 RISL shall not be liable to Utkarsh Classes for any type of loss or damage arising out of use of Utkarsh's e-commerce portal integrated with e-Mitra.
- 5.1.6 Online reports regarding transactions / payments will be available to Utkarsh Classes on reportsemitraapp@rajasthan.gov.in.
